Project Abstract

The project aims to introduce European technology providers to improve energy efficient processes and technologies in eight major manufacturing sectors, namely wood, pulp & paper, iron and steel, cement, rubber, glass, ceramic and food. A market study documenting business opportunity of EE in Malaysia will first be developed locally and the business demand-driven information will be used by our EU partners in Germany and Italy to promote and attract interested companies from Germany, Austria, Netherlands, France, Italy, Portugal and Spain. Participating European companies will demonstrate their industrial EE competence through the co-financed display-cum-meeting area as well as having pre-arranged meetings with Malaysian companies from the main manufacturing sectors. The entire project shall last about 12 months and the one-to-one meeting event shall be held by February/March 2006 in Malaysia.

Objectives

The main objectives of the project are the following:

1. Support Malaysia's Eighth plan strategy to encourage efficient utilisation of energy, particularly in industrial and commercial sectors
2. Improving the EU technology supply bridge - provide opportunities for EU companies to enter the 'Energy Efficiency market' in Malaysia
3. Developing resilient SMEs
4. Provide an effective EU-Malaysia business dialogue platform for matching objectives
5. Promote and increase greater EU-Malaysia trade and economic exchanges and cooperation
6. Promote and protect the environment
